Golf Course Fairways and Tees Athletic Fields	Apply 10 to 14 fl oz per acre in 30 to 90 gal water. Repeat application every 14 to 28 days.
Lawns	Apply 16 to 24 fl oz per acre in 30 to 90 gal water. Repeat application every 4 to 6 weeks.
