This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations, a compatibility test is recommended.

Golf Course Greens and Tees	Maintenance Applications: Apply 0.5 to 1.5 fl oz per 1,000 sq ft every 7 to 14 days. Turf Recovery or Intense Stress: Apply 1.5 to 3.0 fl oz per 1,000 sq ft every 7 to 14 days until turf sufficiently recovers.
Fairways Sports Turf	Apply 0.5 to 1.5 fl oz per 1,000 sq ft. Tank mix with other fertilizers and pesticides for increased absorption and better turf quality. Repeat applications every 14 to 28 days.
Professional Lawn Care	Apply 0.5 to 1.5 fl oz per 1,000 sq ft. Tank mix with other fertilizers and pesticides for increased absorption and better turf quality. Repeat applications every 30 to 45 days.
